## MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

The production of the KiiLto KeraSafe + foil product consists of eight steps: raw material manufacturing, raw material transportation to production site, mixing, coating, printing, cutting, rolling and packaging. During the coating plastic is melted onto a non-woven backing with another non-woven layer attached on top. Finally, the inspected and rolled-up rolls are packed in cardboard boxes on a wooden pallet. The capacity of the cardboard box is 1020 m<sup>2</sup>. The most manufactured package size has been

considered in this study.

Eventually, the product is moved out and transported to the customer in the package.

There is no internal transport on the factory site because manufacturing place is very compact. Only resource that has been used is electricity. Emissions to air are not relevant either.

## TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

The transportation impacts that occur from the delivery of the final product to the construction site cover direct exhaust emissions of fuel, environmental impacts of fuel production, as well as related infrastructure emissions. The transportation distance is defined according to average distance, and is assumed to be 300 km and the transportation method is assumed to be a lorry. Vehicle capacity utilization volume factor is assumed to be 100 % which means full load. Empty returns are not taken into account as it is assumed that return trip is used by the transportation company to serve the needs of other clients. Transportation does not cause losses as product are packaged properly.

Installation does not apply to the product and that is why there are no material or energy consumption to be considered during the installation stage.

### PRODUCT USE AND MAINTENANCE (B1-B7)

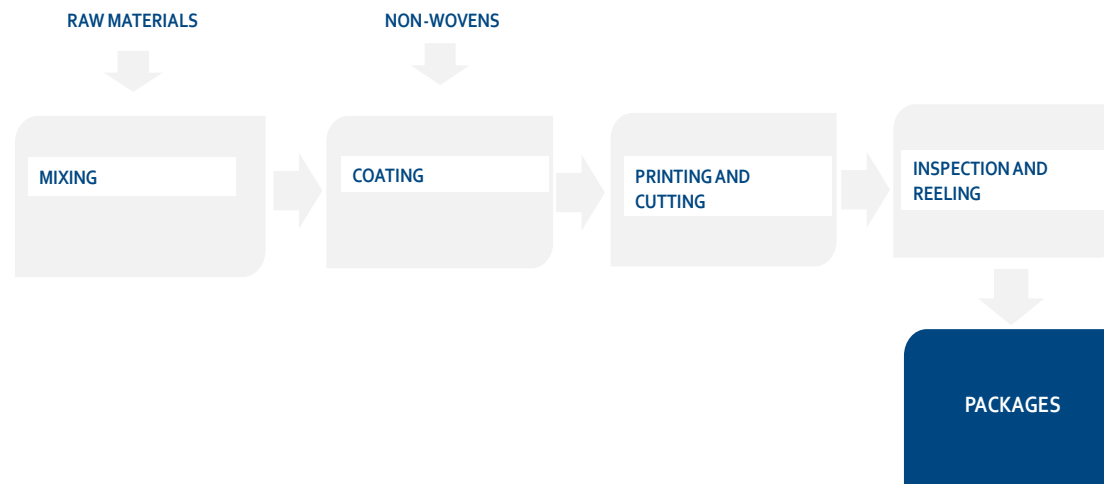
Product use and maintenance is considered negligible due to their minor existence.

Air, soil, and water impacts during the use phase have not been studied.

### PRODUCT END OF LIFE (C1-C4, D)

At the end-of-life, in the demolition phase 100% of the waste is assumed to be collected as separate construction waste. (C1). All of end-of-life product is assumed to be sent to the closest facilities (C2). 80% of the end-of-life product is sent to recycling (C3). 20% is sent to the landfill (C4). Due to the 80% recycling potential, the benefits for recycling brick and load for rock crushing are considered, and the end-of-life product is converted into recycled raw materials (D).

## LIFE-CYCLE ASSESSMENT

### CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.
